Special recognition for the outstanding champions of property rights in 2019



Rep. Dan Bartel, Lewistown Rep.Bartel was the primary sponsor of HJ 28, our resolution to block grazing permit changes requested by the APR. He scored a 122% on the scorecard.



Rep. Wylie Galt, Martinsdale Representing HD 30, Rep. Galt sponsored HB 497, which allows additional elk to be harvested during the shoulder season by increasing the number of elk a person can take from two to three. He scored 108% in our scorecard.



Property Rights in the 2019 Legislative Session

The most important item on our legislative agenda was HJ 28, a resolution from the legislature to the BLM asking for a denial of the American Prairie Reserve's application for a livestock change in use (LCIU) on the eighteen grazing allotments under their control. In addition to requesting to put bison on those allotments, the APR is also seeking permission from the BLM to remove the interior fences. Ultimately the APR intends to use the property under their control as a base for free-roaming bison, and this LCIU is an obvious first step in toward that goal.

Dozens of property owners from the APR target area traveled to Helena to support HJ 28, which passed both chambers of the legislature largely on party-line votes, illustrating a concerning partisan divide on the free-roaming bison issue. As a legislative resolution, HJ 28 did not require approval from the Governor.

HJ 28 is making a difference. Shortly after the conclusion of the legislative session, the bill's primary sponsors, Rep. Dan Bartel and Senator Mike Lang, were invited to share their concerns in a conversation with Secretary of the Interior David Bernhardt. Additionally, a copy of the final version of HJ 28 was hand delivered by UPOM to the acting Director of the BLM in June. There is still work to do, but we are making real progress in blocking the APR's objectives of establishing free-roaming bison and depopulating the communities around them.

Unfortunately, two other important measures related to bison were vetoed by the governor. HB 132 would have made a mild alteration to the legal definitions of "wild" and "domestic" bison to clarify that domestic bison cannot be declared wild by bureaucratic declaration. HB 332 would have given authority to county governments to approve any translocation of wild bison into their jurisdiction.

The governor vetoed several other bills that UPOM supported in the 2019 legislative session, two of which are included in this scorecard. HB 265 would have restored the Land Board's oversight authority over major conservation easements entered into by FWP. And HB 394 would have improved the tax appraisal process to ensure fairness for homeowners and other property owners.

Despite these veto setbacks inflicted by the Governor, the remainder of our legislative agenda had positive outcomes in the 2019 legislative session. One of our top bills, HB 229, was passed with unanimous support in both chambers. This bill corrected a bad precedent set by the 9th Circuit Court of Appeals whereby they declared fossils, including dinosaurs, belonged to the mineral owners in a split estate. Fossils had previously belonged to the surface estate, which HB 229 restored.

SB 253 established an innovative new way for county governments to conduct tax lien auctions, and will ensure that property owners facing an auction of their property will be treated more fairly and recoup some equity from their property. HB 497 liberalizes elk shoulder seasons to allow more elk to be harvested. HB 286 reversed a Bullock administration practice of asserting claims on water rights on state leases.

There were fewer outright attacks on property rights than we've seen in prior sessions, but those bad ideas have not died out entirely. Significantly, the chief opponent to property rights, Senator Tom Jacobsen, was back again this session with an attempt to effectively prohibit property owners from placing gates on private roads that might lead to public land. Despite our objections SB 224 was heavily amended in Senate committee and passed the Senate, but was killed in a House committee. Our experience with SB 224 shows how narrow our margins are on protecting property rights.

We're looking forward to working with a new administration in the 2021 legislative session, and working on a proactive agenda to enhance property rights even more after the successes we had in 2019.

Bill Descriptions for UPOM's Legislative Scorecard

The following bills from the 2019 Legislative session were used to grade each legislator. The bills are weighted according to their impact—positive or negative—on property rights. Bonus points based on these weights are added to, or subtracted from, the scores of the primary sponsor of each bill included in our scorecard.

UPOM's 'Property Rights Heroes' are selected by UPOM's Board of Directors as those legislators who sponsored legislation, who scored over 100% on the scorecard, or who have exhibited an exemplary commitment to protecting private property rights throughout their tenure in the Montana State Legislature.

HB 132—Clarify definition of bison

Rep. Holmlund, R-Miles City

Weight: 2 Support

Revised the definition of bison and buffalo to specify that a bison that had previously been subject to the per capita fee could never be classified as "wild". This bill was important policy to prevent domestic bison from being reclassified as wildlife. House Vote: 3rd Reading on 3/27, passed 54-45 Senate Vote: 3rd Reading on 3/22, passed 30-20 Final Status: Vetoed by Governor

HB 265—Revise laws related to approval of FWP easements

Rep. White, R-Bozeman Weight: 2 Support

This bill would have required Land Board approval of FWP easements costing the state over \$100,000. The Land Board had historically approved such easements until Governor Bullock changed that practice in 2018, removing transparency from the process.

House Vote: 3rd Reading on 2/18, passed 54-44 Senate Vote: 3rd Reading on 4/8, passed 26-23 Final Status: Vetoed by Governor

HB 229—Clarify dinosaur bones and fossils are part of surface estate

Rep. Hamlett, D-Cascade

Weight: 4 Support

This bill was a response to a new legal precedent created by the federal 9th Circuit Court of Appeals in which they awarded ownership of fossil remains, including dinosaur fossils, to the mineral owner in a split estate. HB 229 clarified Montana law to unequivocally state that fossil remains are part of the surface estate.

House Vote: 3rd Reading on 2/23, passed 100-0 Senate Vote: 3rd Reading on 3/22, passed 50-0

Final Status: Became Law

HB 332—Require county approval to relocate bison

Rep. Kassmier, R-Fort Benton Weight: 4 Support This simple bill specified that county commissioners must approve any translocation of bison into their jurisdiction.

House Vote: 3rd Reading on 2/26, passed 56-41 Senate Vote: 3rd Reading on 3/8, passed 29-20 Final Status: Vetoed by Governor

SB 224—Generally revise laws related to county road access

Senator Jacobson, D-Great Falls

Weight: 5 Oppose

SB 224 was an attempt to force access across private land. Under this bill, activists could claim any road to be public and ask the county commission to impose a \$500 per day fine on the landowner for gating that road.

House Vote: Blast Motion on 4/9, failed 42-55 Senate Vote: 3rd Reading on 3/9, passed 31-13 Final Status: Died in Committee

SB 253—Revise the tax lien and tax deed process for residential property

Senator C. Smith, R-Billings

Weight: 3 Support

Overhauled county treasurer procedures regarding tax liens that end up in auction. Ensures that the property owner has an opportunity to retain some equity from their property. This legislation was developed in conjunction with the Pacific Legal Foundation with the intention that it will be used as a model bill for other states.

House Vote: 3rd Reading on 4/12, passed 89-8 Senate Vote: 3rd Reading on 4/18, passed 49-1 Final Status: Became Law

Rep. Joshua Kassmier, **Fort Benton**

Rep. Kassmier carried HB 332, which gives local governments a role in determining if bison may be translocated into their jurisdictions. He scored 103% on our scorecard.



Rep. Bradley Hamlett, Cascade Rep. Hamlett succeeded in achieving unanimous approval of HB 229, the legislation that clarifies that fossil remains belong to the surface owner in a split estate. He scored highest among Democrats, at 78%, on our scorecard.



HB 497—Allow additional elk to be harvested during shoulder season

Rep. Galt, White Sulphur Springs

Weight: 3 Support

Increases the number of elk a person may take from two to three.

House Vote: 3rd Reading on 2/27, passed 59-40 Senate Vote: 3rd Reading on 4/2, passed 28-21

Final Status: Became Law

HJ 28—Joint resolution requesting denial of American Prairie Reserve grazing permit

Rep. Bartel, Lewistown Weight: 5 Support

A resolution to the Bureau of Land Management asking that they reject the APR's application to change grazing practices on allotments under their control. The APR's application is the first step to establishing a free-roaming bison herd.

House Vote: 3rd Reading on 3/1, passed 59-40 Senate Vote: 3rd Reading on 4/8, passed 30-19

Final Status: Resolution Passed

HB 286—Revise water right laws related to state water claims

Rep. Redfield, R-Livingston Weight: 4 Support

Reversed a controversial practice implemented by Governor Bullock where DNRC would assert a water rights claim for water that originated on private land for use on a state lease.

House Vote: 3rd Reading on 4/5, passed 90-9 Senate Vote: 3rd Reading on 4/2, passed 42-7

Final Status: Became Law

SB 299—Generally revise laws related to sage grouse conservation

Senator Lang, R-Malta Weight: 4 Support

Requires the Montana Sage Grouse Oversight Team to report the number of projects required to pay compensatory mitigation

for the preservation of sage grouse to the Environmental Quality Council. This bill also seeks to limit the ability of MSGOT to require

compensatory mitigation.

House Vote: 3rd Reading on 4/8, passed 62-35 Senate Vote: 3rd Reading on 4/24, passed 46-3

Final Status: Became Law

Bill descriptions cont.

HB 394—Revise property tax appraisal and tax appeal process

Rep. Hertz, R-Polson Weight: 3 Support

A bill designed to make the tax appeals process more fair for property owners. Would have allowed property owners to collect attorney fees, and changed certain appraisal practices for residential property. House Vote: 3rd Reading on 2/26, passed 78-19 Senate Vote: 3rd Reading on 4/4, passed 33-15 Final Status: Vetoed by Governor

SB 300—Generally revise property laws to protect property rights

Senator Bogner, R-Miles City

Weight: 1 Support

Provides that an HOA may not impose more onerous restrictions on a property owner than those restrictions that existed when the property was originally acquired. House Vote: 3rd Reading on 4/5, passed 73-24 Senate Vote: 3rd Reading on 4/12, passed 39-11

Final Status: Became Law
